Investment objective

The Fund aims to track as closely as possible the returns of the MSCI Japan Climate Paris Aligned Index (the Index). The Fund will invest in or gain exposure to shares of companies which make up the Index. The Fund qualifies under Article 8 of SFDR.



Investment strategy

The Index is a subset of the MSCI Japan Index (the Parent Index) and made up of shares of large and mid-sized companies (as measured by the market value of their shares) of the Japanese markets, as defined by the Index Provider. The Index is designed to support investors seeking to pursue opportunities arising from the transition to a lower-carbon economy while aligning with the Paris Agreement requirements. It excludes shares of companies with exposure to controversial weapons, ESG controversies, tobacco, environmental harm, thermal coal mining, oil and gas, and power generation. The Fund is passively managed and aims to invest in the shares of the companies in generally the same proportion as in the Index. The Fund may invest up to up to 35% of its assets in securities from a single issuer during exceptional market conditions, up to 10% in other funds, up to 10% in total return swaps and up to 5% of its assets in contracts for difference. Main risks




